## 2. Public Perceptions of Mental Health and Suicide Prevention Survey Results

# a. Increased Comfort Discussing Suicide

*Observations*: There has been a notable increase in comfort when discussing suicide compared to the past. A surprising decline was observed in comfort levels between 2022-2024.

## *Possible factors*:

- o Greater comfort discussing mental health and suicide virtually.
- o More acceptance of mental health issues during the pandemic.
- o Unclear data points create some confusion in interpreting the results.

### b. Awareness of 988

*Observation*: A need to increase awareness of 988 as a crisis resource. *Suggestions*:

- o Incorporate 988 information in community settings (e.g., flu clinics).
- o Address possible deterrents like the term 'crisis.'
- o Educate the public on what to expect when using 988.
- Utilize billboards and signage to increase visibility.

### c. Barriers to Contacting Crisis Services

*Observations*: Cost was highlighted as a significant barrier, which is disappointing given the importance of accessible support. Some respondents reported no barriers.

## 3. Everyone is an Asset Builder (EAB) Training

#### a. Overview

Developed by The Search Institute, this evidence-based program has been in use for over 50 years. It has a focus of strengthening protective factors within communities through internal and external assets. This training and data collection emphasizes

that we are already asset builders and can enhance our impact. The purpose is to shift perspectives toward a positive, motivating, and inspiring approach. This is data-driven and evidence-based.

### b. Potential Collaboration

Youth Service Bureaus (YSBs) could revive these trainings.

Schools conducting related surveys might provide an opportunity to leverage Local Prevention Councils (LPCs).

Suggestion: Potential EAB training in August with Joseph Gorman.
